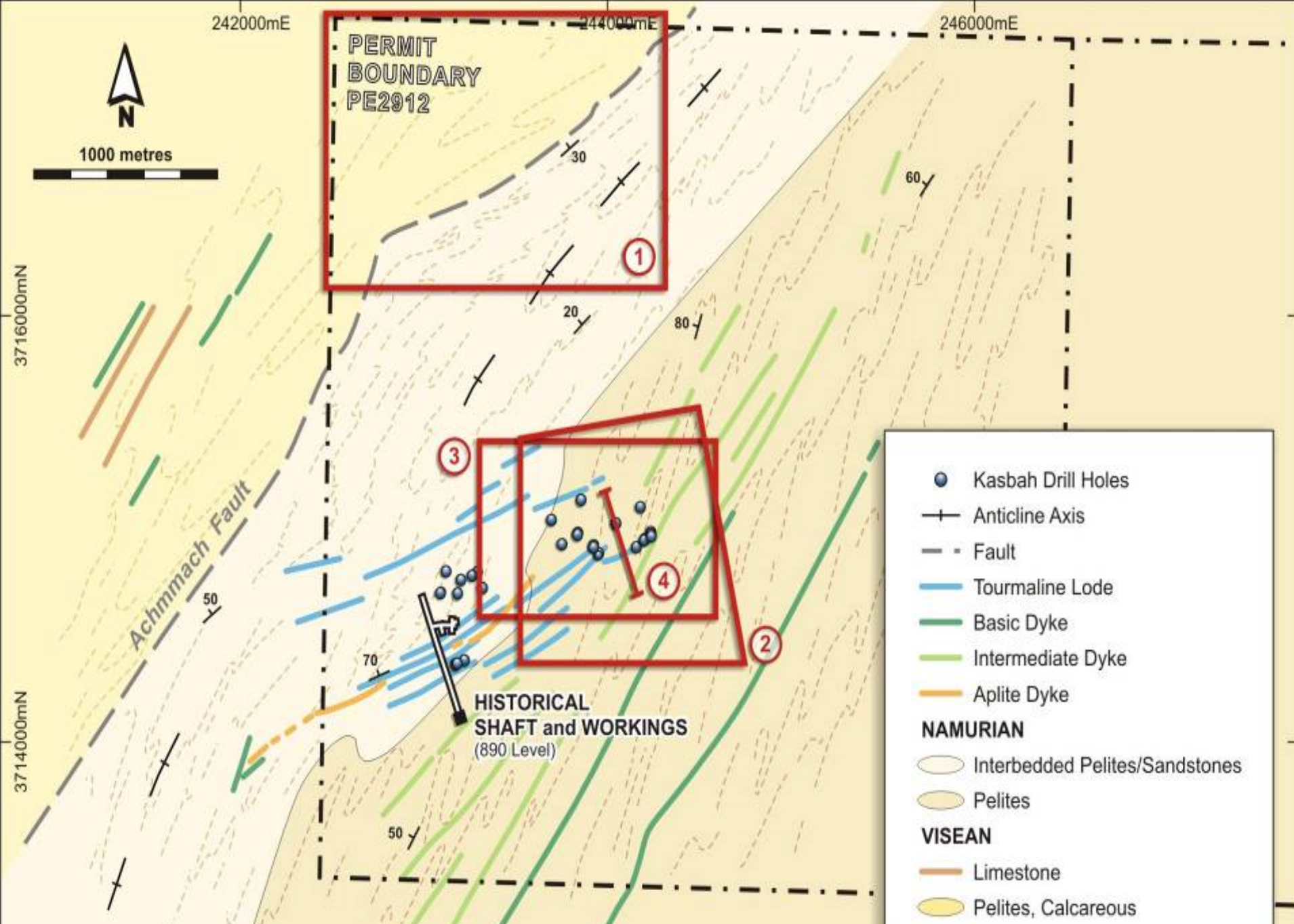

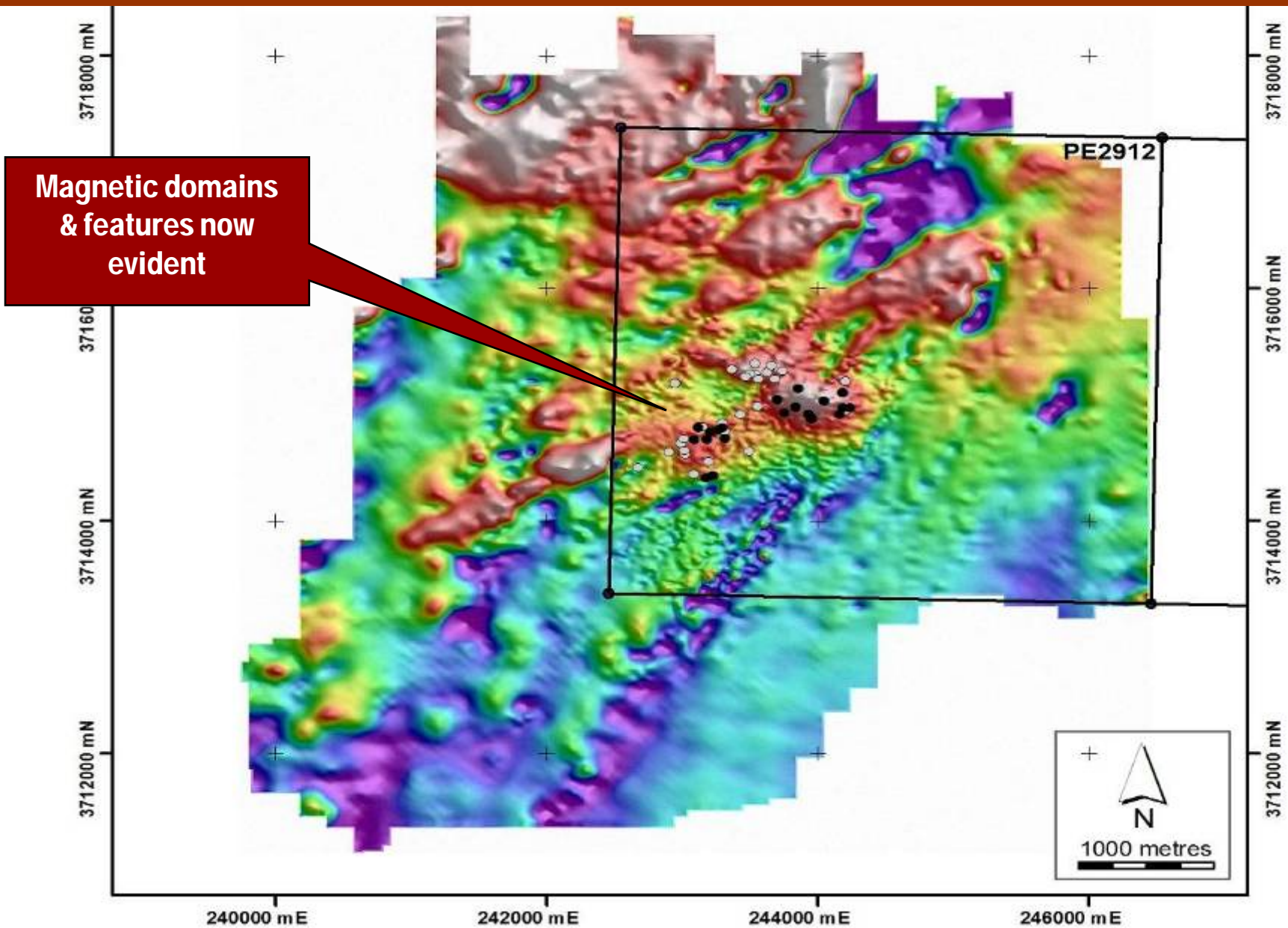
- Achmmach Option Agreement Extended to June 2011**

- Surface sampling extends strike of Tamlalt Gold prospect**



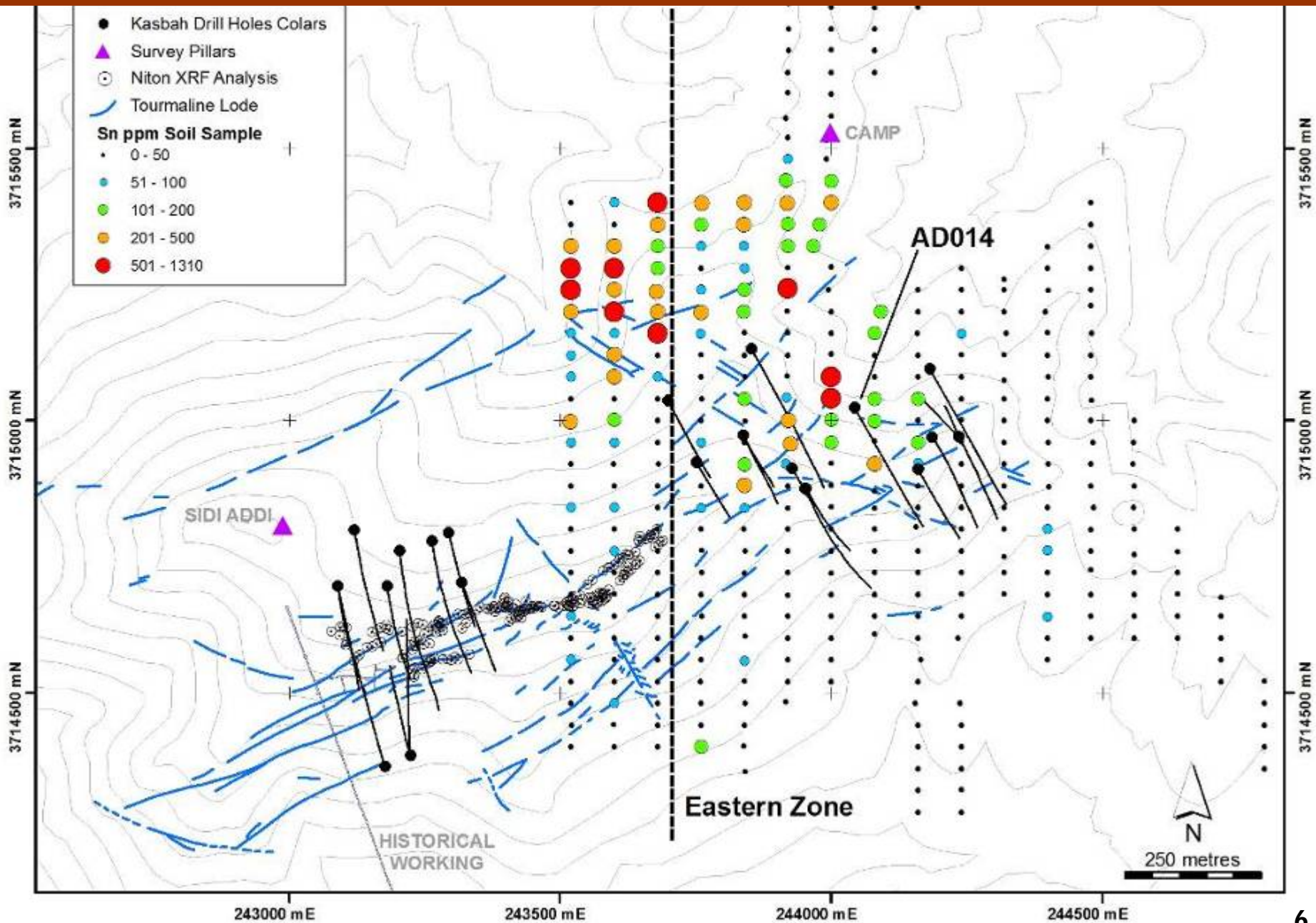


Achmmach - Work Areas

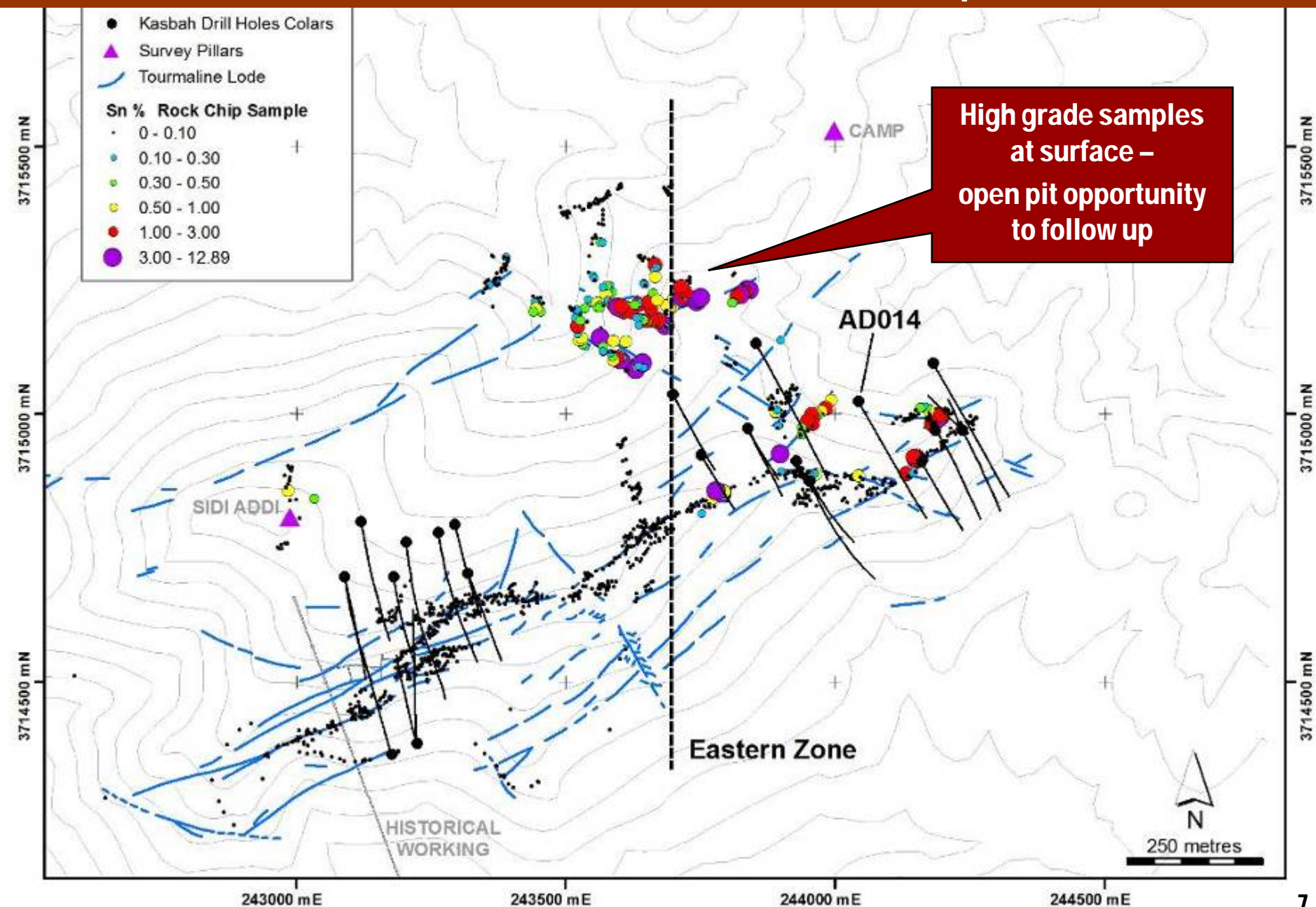
Achmmach – Ground Magnetic Image



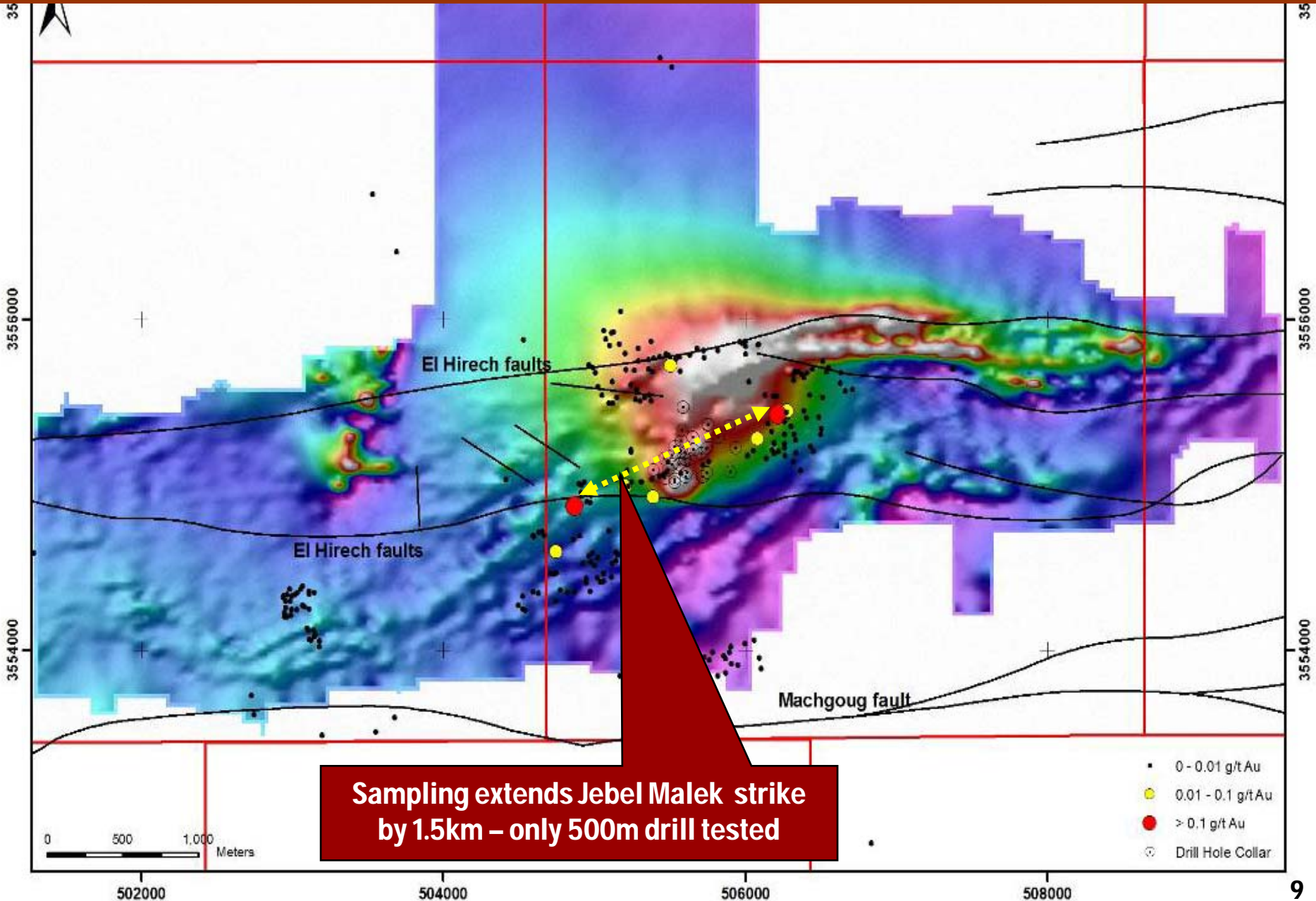
Work Area 3 – Achmmach Eastern Zone Soil Sample Results and NITON Analysis Results
